#### MINUTES OF 2ND ANNUAL GENERAL MEETING OF DIA

The attendance was recorded as per the Attendance Register.

- The President Mr. Aloke Sen called the meeting to order, and on the request of the Secretary, Mr. Brijen Joshi, he took the chair. Mr. Kallol Baroi, Vice President Mr. Brijen Joshi, Secretary and Mr. Rakesh Agarwal, Treasurer were also requested to be on the dais.
- The Agenda of the meeting was read out by the Secretary ,Mr. Brijen Joshi.
- President, Mr. Aloke Sen requested the secretary Mr. Brijen Joshi to start the proceedings of the meeting. Brijen Joshi invited PRO Mr. Deborup Das to read out the Minutes of the last Annual General Meeting.
- Mr. Deborup Das read out the Minutes of the last Annual General Meeting. Then he proposed all the members to adopt the Minutes of the last Annual General Meeting. It was seconded by DIA Secretary ,Mr. Brijen Joshi and adopted unanimously by the House.
- Mr. Brijen Joshi, Secretary of DIA read out Annual Report which is a brief account of the activities of DIA in the year 2014-15. He started from the formation of the Governing Committee after the first AGM and thenbriefed about the activities conducted and events organized by the present Governing Committee of DIA in the year 2014-15 including the extended months upto the 2<sup>nd</sup> AGM. He said that regular programmes were organized by DIA Committee for its members. He spoke about exclusive DIA events by Hettich, Jaquar Roca and Wilo. He spoke about annual events DIAFEST and Family PICNIC. He also spoke about DIA's participation in ACETEC 15 in Kolkata as a great achievement. He mentioned that all these meetings and events boosted the feeling of togetherness between DIA members and their families. He said that Governing Committee reviewed and updated the Mission and Bye Laws of the Association.
- Mr. Rakesh Agarwal, Treasurer of DIA, read out the Audit Reports for the year ending 31<sup>st</sup> March 14 and 31<sup>st</sup> March 2015. He also explained some expenditure heads for the better understanding of the House. He proposed The Audited accounts and Financial Reports for the year 2013- 14 with year ending 31<sup>st</sup> March 2014 and for the year 2014-15 with year ending 31<sup>st</sup> March 2015 were placed before the House by the treasurer Mr. Rakesh Agarwal for adoption, after being seconded by the Vice President Mr. Kallol Baroi, were then adopted unanimously for the Assessment Year 2014-15 and 2015-16.

The next Agenda to appoint Auditors and Bankers for the year 2015-16 was moved by Mr. Rakesh Agarwal. He proposed to re-appoint M/s Hemant K Agarwal& Company as Auditors for DIA and continue with HDFC bank as Bankers of DIA which was unanimously accepted by the House.

DIA Secretary Mr. Brijen Joshi ,requested new DIA Members to introduce themselves to the House. Mr. Anup Paria, Mr. Amit Sharma, Mr. Archit Sarogi, Mr. Dipak Dubal , Mr. Indranil Banerjee , Mr. Mukesh Goel, Mr. Ravi Pal Mehta and Mr. Rajesh Sharma introduced themselves to the House. Mr. Brijen Joshi read out the names of new members Mr. Joydeep Sanyal, Mr. Pradip Jain, Mr. Praveen Jalan, Ms. Khusboo Modi, Mr. Rahul Saraiwala, Ms Rashmi Bajaj and Ms Tanvi Dubal as they were not present at the time of Introduction Session.

Then updated video - "Journey of DIA" was shown to the House. Immediately after this, Mr. Brijen Joshi regested Mr. Aloke Sen to start the Open Hour Session.

Mr. Aloke Sen put forward three proposals to the House and asked for their opinion and consent. He said that AGM should be conducted on time every year. He also mentioned that no Board Member should join the Board / Governing body of other similar organization. And also a DIA member who is in Board/ Governing body of any other similar organization should not contest Election for any DIA Office Bearer post. Then he emphasized on the necessity of an exclusive office of DIA regarding which he invited Governing Committee member Mr. Ravi Dugar who had some offer for DIA office on rent. All the proposals were accepted and appreciated by the House. Then Mr. AlokeSen Invited the House for the open hour Session. Mr. Kallol Baroi requested all the members present in the House to participate in the session.

Mr. Rakesh Agarwal asked for the opinion of the House for the increase in Co member's Subscription and the ratio between designer members and co members which should be followed in future. Mr. Kallol Baroi explained why the Governing Committee is so cautious and selective about taking new co members. Mr. Sabir, Mr. Kishore Belani and Mr. Anand Gupta gave their valuable suggestions on the matter. Mr. Anand Gupta said that there should not be any restrictions on inclusion of new Co Members. Mr. Kallol Baroi assured the House that the Governing Committee would adopt a flexible approach on this matter.

Mr. Manish Doshi appreciated and praised the good work done by the present committee. He wooed the Board for even more better performance in future.

Mr. Manish Chhaochharia spoke about China Fair and a possible DIA involvement in organizing that Mr. Kallol Baroi made it clear that DIA cannot sponsor any such Trips at the moment but self sponsored small groups can be made between like-minded DIA members who are interested in going for such knowledge sharing trips and exhibitions. He asked Manish to take an initiative and requested all those members who are interested to forward a mail. He requested Mr. Sunil Chowdhury and Mr. Mandeep Manchanda to take an initiative with Manish in this matter.

Mr. Manjit Matharoo gave emphasis on formation of sub committees and organizing workshops. Mr. Kallol Baroi requested the women members of the Association to come forward for the active participation. He also gave stress on CSR activities to be organized by DIA in future.

DIA PRO Mr. Deborup Das requested Product Members to host Tea Meets for DIA Members. It would see increased interaction between DIA members. Mr. Sanjeev Jalan spoke about creating a Corpus by raising funds from members .Mr. Kallol Baroi, Mr. Pramod Kabra and Mr. Manjeet Matharoo spoke about Carpenters workshops.
